



Waiver of Liability, Indemnification, Medical Release, and Photo/ Video Release Authorization

Waiver of Liability and Indemnification:

I hereby consent to receive medical treatment which may be deemed advisable in the event of injury, accident or illness during this activity or event. This release, indemnification, and waiver shall be construed broadly to provide a release, indemnification, and waiver to the maximum extent permissible under applicable law.

I, the undersigned participant, affirm that I am at least 18 years of age and am freely signing this agreement. I have read this form and fully understand that by signing this form I am giving up legal rights and/or remedies which may otherwise be available to me regarding any losses I may sustain as a result of my participation. I agree that if any portion is held invalid, the remainder will continue in full legal force and effect.

Because physical exercise can be strenuous and subject to risk of serious injury, Ameanspinn urges & encourages you to obtain a physical examination from a doctor prior to using any exercise equipment or participating in any exercise activity. You agree that if you engage in any physical exercise or activity, or use any Studio amenity on the premises, you do so entirely at your own risk. You agree that you are voluntarily participating in these activities and use of these facilities and premises and assume all risks of injury, illness, damage or even death, or loss of by theft of any personal property. You expressly agree to release and discharge Ameanspinn, and all affiliates, employees, agents, representatives, successors, or assigns, from any and all claims or causes of action. This waiver and release of liability includes, without limitation, all injuries to you which may occur, regardless of negligence, as a result of (a) your use of any exercise equipment, products and Studio amenities, (b) the sudden and unforeseen malfunctioning of any equipment, (c) our instruction or supervision, and (d) your slipping and/or falling while in the Studio, or on the Studio premises, including adjacent sidewalks and parking areas.
